Bid Results **Background/Summary:** This project was originally bid in 2018; however, when only one bid was received and it was more than \$100,000 over the engineer's estimate, Council decided to reject all bids on June 25, 2018. The project was re-bid last month and in accordance with the Invitation to Bid for subject project, Public Works staff opened four sealed bids on Tuesday February 5, 2019 at 2:00 pm. The responsive low bid was submitted by Williamson Construction LLC, whose total bid was in the amount of \$220,336.44 (Schedule A \$155,547.89 and Schedule B \$64,788.55). The engineer's estimate was \$206,173 (Schedule A \$156,926 and Schedule B \$49,249). Improvements within bid schedule "A" include excavation and removal of bad material, importing lightweight-fill material near WSDOT's bridge structure, repair roadway, and providing ADA improvements. Schedule "B" includes providing handicapped (ADA) ramp retrofits along H Street along the school frontage **Budget Implications:** Current Budget New Budget Request Non-Budgetary A Transportation Improvement Board (TIB) grant will pay 85.1573% of Schedule A and balance will be paid out of Fund 333. Schedule B is not grant-eligible. Recommendation: Staff offers the following options for consideration by the Council. 1. Accept the bid and authorizes the City Manager to enter into a unit price contract with Williamson Construction pending TIB's approval in the amount of \$220,336.44. 2.
