- Crisis assistance involving one-on-one meetings with clients to coordinate emergency financial assistance for things such as utilities, prescriptions, groceries and shortterm lodging;
- Clothing Assistance;
- Winter Coat Drive;
- Holiday assistance;
- Financial Literacy Classes; and
- Chaplain services.
